

Memorandum of Cooperation
between *(your Ministry or Government department)*
and the
International Raelian Movement

This agreement is made between *(your Ministry or Government department)* and the International Raelian Movement (the parties) for the purposes of coordinating actions and responsibilities regarding a project to construct an Embassy for Extra Terrestrials and related works and facilities (the project).

Now therefore, the parties agree as follows:

1. GENERAL PROVISIONS

- 1.1. The purpose of the memorandum is to coordinate actions and responsibilities for the project as part of a range of programs for national/state development approved by the government of *(your country)*.
- 1.2. The parties' cooperation shall be conducted according to the constitution of *(your country)*, its laws and the articles of any contracts made between the two parties.
- 1.3. The parties' cooperation shall be dependent on mutual respect between the parties, regular meetings to progress the project and mutual confidentiality of the parties' activities, unless prohibited by relevant laws.

2. GENERAL GUIDANCE OF COOPERATION AND ACTIVITIES

- 2.1. The *(your Ministry or Government department)* undertakes to support the development of the project by the International Raelian Movement, including any special diplomatic initiatives that may be necessary.
- 2.2. The International Raelian Movement undertakes to establish an official representative's office in *(your country)* and commence the development of the project, in accordance with the attached prospectus, by *(day / month / year)*.

3. PROJECT DEVELOPMENT AND IMPLEMENTATION IN *(YOUR COUNTRY)*

- 3.1. The International Raelian Movement, or a special purpose subsidiary properly established by that party, shall set up a registered office in *(your country)* to provide effective management and supervision of the project, all in accordance with the relevant laws of *(your country)*.
- 3.2. The *(your Ministry or Government department)* shall support the activities of the International Raelian Movement to cooperate with other ministries and authorities in development of the project.

- 3.3. The parties will jointly agree on the appropriate time to inform the public about this project.
- 3.4. The International Raelian Movement shall employ citizens of *(your country)* for constructional works on the project in order to support local employment.
- 3.5. The International Raelian Movement shall cooperate with registered companies in *(your country)* for the supply of goods, materials and services for the project in order to support *(your country)* businesses.
- 3.6. The parties shall jointly agree on relative responsibilities for developing and operating physical and social infrastructure to support the project and to benefit *(your country)* citizens living close to the site of the project.

4. COORDINATION

- 4.1. Implementation of this memorandum shall be coordinated by the *(your Ministry or Government department)* and the office of the International Raelian Movement in *(your country)*.
- 4.2. The parties shall cooperate to prepare a program for the development of the project and shall meet regularly to progress the project.
